You won't ever be considered a "snitch" because no one will know it was you but you have your conscience completely cleared.

Investigators believe that the cow was intentionally shot, due to where the cow was located. The cow was valued at approximately \$9,000.00, however the cow was recently inseminated, raising the value of that cow to approximately \$15,000.00.

The suspect forced entry into the residence and removed numerous pieces of electronic equipment including an X-Box 360 with several games and a laptop computer. Total loss is estimated to be in excess of \$1,200.00.
